Court ruled that a person who is using medical marijuana under a doctor's prescription can still be prosecuted under the federal law that bans the possession or use of marijuana. Alaska is one of 10 states that have state laws that legalize possession and use of marijuana for medical reasons.

Alaska goes one step further. The state Supreme Court has ruled that Alaska's privacy laws allow the use and possession of small amounts of marijuana for any reason. It still is a federal crime, but local law enforcement takes a hands-off approach and does not pursue marijuana users under the federal law.
